## **2. Objective of the Session**

The main objective of this educational visit was to introduce students to the fundamental concepts of taxation and its relevance in personal finance and business management. The session also aimed to bridge theoretical learning with professional insights, promoting awareness of the taxation framework and compliance structure in India.

### **3. Session Details**

The Faculty of Liberal Studies at Atmiya University, Rajkot, in collaboration with the Institute of Chartered Accountants of India (ICAI), Rajkot Chapter, organized an Educational Visit & Professional Talk on the Basics of Taxation on 26th July 2025.

The session was conducted by CA Raj Marvaniya, the Current Chairman of ICAI Rajkot Branch, who guided students through the practical aspects of the Indian taxation system. He began by explaining the structure of direct and indirect taxes, the importance of tax compliance, and the role of taxation in nation-building.

Students gained insights into Income Tax fundamentals, GST mechanisms, and the ethical responsibilities of taxpayers and professionals. CA Marvaniya also discussed real-life case examples, demonstrating how taxation principles apply in business scenarios and personal income management.

The session was highly interactive, as students asked questions about career opportunities in finance and taxation, and how liberal studies students can align analytical and critical thinking skills with financial literacy.

The visit concluded with a tour of the ICAI Rajkot premises, where students observed the working environment of accounting professionals and learned about the institute's role in promoting financial discipline and integrity in professional practice.
